1. **SECOND READING: Amended Bill No. 6390-15, Section VIII: AN ORDINANCE ESTABLISHING THE ANNUAL PROPERTY TAX LEVY RATE FOR THE CITY OF RAYTOWN GENERAL OPERATING FUND AND THE PARK FUND FOR THE YEAR 2015.** Point of Contact: Mark Loughry, Finance Director.
