NEW BUSINESS

1. **FIRST READING: Bill No. 6614-22, Section III-A-9. AN ORDINANCE REPEALING ORDINANCE NO. 5702-22 AUTHORIZING AND DIRECTING SUBMISSION AT THE GENERAL ELECTION TO BE HELD NOVEMBER 8, 2022 TO THE QUALIFIED VOTERS OF THE CITY OF RAYTOWN, MISSOURI, THE QUESTION OF WHETHER THE CITY SHALL IMPOSE AN ADDITIONAL SALES TAX IN THE AMOUNT OF THREE PERCENT ON THE RETAIL SALE OF ADULT USE MARIJUANA.** Point of Contact: Jennifer Baird, City Attorney.

Jennifer Baird, City Attorney, explained the reason for this emergency meeting was because it was recently discovered that the City is unable to put the question of imposing a sales tax for recreational use marijuana on the ballot at this time. Further the final certification date for the November 8, 2022 ballot was Tuesday, August 30, 2022 at 5:00 p.m. This meeting date and time was the only time that a majority of the Board of Aldermen could meet to repeal the ordinance placing the recreational use marijuana question on the ballot before the final certification date.

Ms. Baird presented the item and requested that the Board of Aldermen suspend the rules to allow for immediate second reading so that the ballot question approved in Ordinance 5702-22, regarding a sales tax on the sale of recreational use marijuana, could be removed from the November 8, 2022 ballot.

Alderman Myers, seconded by Alderman Scott, made a motion to suspend the rules and hold an immediate second reading. The motion was approved by a vote of 6-0-4.
